For the purpose of transitioning a child's biological sex as determined by the sex organs, chromosomes, and endogenous profiles of the child or affirming the child's perception of the child's sex if that perception is inconsistent with the child's biological sex, a physician or health care provider may not: (1) perform a surgery that sterilizes the child, including: (A) castration; (B) vasectomy; (C) hysterectomy; (C) hysterectomy; (C) pencount; (G) penceunty; (F) orchiectomy; (G) penceunty; (G) penceunty; (H) phalloplasty; and (I) vaqinoplasty;</u>
