A BILL TO BE ENTITLED AN ACT

relating to the enforcement of commercial motor vehicle safety standards in certain counties.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 644.101(c), Transportation Code, as amended by Chapters 74 (H.B. 2749) and 429 (S.B. 901), Acts of the 87th Legislature, Regular Session, 2021, is reenacted and amended to read as follows:

- A sheriff or a deputy sheriff of any of the following (c) counties is eligible to apply for certification under this section:
 - (1)a county bordering the United Mexican States;
- a county with a population of less than 1,000, part of which is located within 75 miles of an international border;
- (3) a county with a population of 700,000 or more; (4) a county with a population of 400,000 or more that borders the county in which the State Capitol is located; [or]
- a county with a population of less than 250,000 (5)
