BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 521.101, Transportation Code, is amended by amending Subsection (m) and adding Subsection (n) to read as 1-25 1-26 1-27 follows:

1-28 The department shall adopt procedures for the issuance (m) 1-29 of a personal identification certificate to a person who surrenders 1-30 the person's driver's license at the time of applying for the 1-31 certificate. The procedures:
