1-19 A BILL TO BE ENTITLED AN ACT

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 351.1015(a)(5), Tax Code, is amended to read as follows:

(5) "Qualified project" means:

(A) a convention center facility or venue and any

(B) a multipurpose arena or venue that includes a livestock facility and is located within or adjacent to a recognized cultural district, and any related infrastructure, that

SECTION 2. Section 351.1015, Tax Code, is amended by amending Subsection (b) and adding Subsection (j) to read as follows:

- $\frac{(1)}{650,000}$ a municipality with a population of at least 650,000 but less than 750,000 according to the most recent federal decennial census; or
- (2) a municipality that contains more than 70 percent of the population of a county with a population of 1.5 million or more.
- (j) A local government corporation may act as a municipality under this section and is considered to be a municipality for purposes of this section.

SECTION 3. This Act takes effect September 1, 2023.
