1-19 A BILL TO BE ENTITLED
 1-20 AN ACT

1-21 relating to address information contained on reports of political
 1-22 contributions and expenditures made available on the Internet by
 1-23 the Texas Ethics Commission.

1-24 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-25 SECTION 1. Section 254.036, Election Code, is amended by
 1-26 adding Subsection (b-1) to read as follows:

1-27 (b-1) In prescribing the format of a report filed with the
 1-28 commission under Subsection (b), the commission shall ensure the
 1-29 report includes a space to indicate whether the address of an
 1-30 individual listed as having received a political expenditure is a
 1-31 residence address.

1-32 SECTION 2. Section 254.0401, Election Code, is amended by
 1-33 amending Subsection (e) and adding Subsection (e-2) to read as
 1-34 follows:

1-35 (e) Before making a report filed under Section 254.036(b)
 1-36 available on the Internet, the commission shall remove each
 1-37 portion, other than city, state, and zip code, of:

1-38 (1) the address of a person listed as having made a
 1-39 political contribution to the person filing the report; and

1-40 (2) the residence address of an individual listed as
 1-41 having received a political expenditure if the individual's address
 1-42 is indicated in the space described by Section 254.036(b-1) as
 1-43 being a residence address. ~~[The address information removed must~~
 1-44 ~~remain available on the report maintained in the commission's~~
 1-45 ~~office but may not be available electronically at that office.]~~

1-46 (e-2) The address information the commission removes under
 1-47 Subsection (e) must remain available on the report maintained in
 1-48 the commission's office but may not be available electronically at
 1-49 that office.

1-50 SECTION 3. The changes in law made by this Act apply only to
 1-51 a report of political contributions and expenditures under Chapter
 1-52 254, Election Code, that is required to be filed on or after January
 1-53 1, 2026.

1-54 SECTION 4. This Act takes effect September 1, 2025.
