A BILL TO BE ENTITLED AN ACT

1-19 relating to certain policies and procedures for health care 1-20 specialty consultations in certain child abuse or neglect 1-21 investigations and assessments.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 1-23 SECTION 1. Section 261.3017, Family Code, is amended by amending Subsections (c-1) and (d) and adding Subsections (c-3) and 1-24 1-25 (e-1) to read as follows:

(c-1) For a case in which a specialty consultation is required by Subsection (c), the department shall refer the case to a 1-26 1-27 1-28 physician who:
