1-17 A BILL TO BE ENTITLED
1-18 AN ACT

1-19 relating to the designation of a Texas Department of Transportation
1-20 building in Starr County as the Eduardo "Eddie" Gracia, Jr., P.E.,
1-21 Area Engineer and Maintenance Facility.

1-22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-23 SECTION 1. Subchapter Y, Chapter 201, Transportation Code,
1-24 is amended by adding Section 201.2004 to read as follows:

1-25 Sec. 201.2004. EDUARDO "EDDIE" GRACIA, JR., P.E., AREA
1-26 ENGINEER AND MAINTENANCE FACILITY. (a) The building in which, on
1-27 January 1, 2025, is located the office of the area engineer for
1-28 Starr County is designated as the Eduardo "Eddie" Gracia, Jr.,
1-29 P.E., Area Engineer and Maintenance Facility.

1-30 (b) Subject to Subsection (c), the department shall:

1-31 (1) design and construct markers at the site of the
1-32 facility indicating the designation as the Eduardo "Eddie" Gracia,
1-33 Jr., P.E., Area Engineer and Maintenance Facility and any other
1-34 appropriate information; and

1-35 (2) update existing signage along the highway on which
1-36 the facility is located to reflect the designation described by
1-37 Subdivision (1).

1-38 (c) The department is not required to design or construct a
1-39 marker or update existing signage under this section unless a grant
1-40 or donation of private funds is made to the department to cover the
1-41 cost of the design and construction of the marker or update of the
1-42 existing signage.

1-43 (d) Money received under Subsection (c) shall be deposited
1-44 to the credit of the state highway fund.

1-45 SECTION 2. This Act takes effect immediately if it receives
1-46 a vote of two-thirds of all the members elected to each house, as
1-47 provided by Section 39, Article III, Texas Constitution. If this
1-48 Act does not receive the vote necessary for immediate effect, this
1-49 Act takes effect September 1, 2025.
