1-17 A BILL TO BE ENTITLED
 1-18 AN ACT

1-19 relating to an interstate compact for the liquefied natural gas
 1-20 industry.

1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 SECTION 1. Title 7, Government Code, is amended by adding
 1-23 Chapter 760 to read as follows:

1-24 CHAPTER 760. GULF STATES LIQUEFIED NATURAL GAS INDUSTRY COMPACT

1-25 Sec. 760.001. AUTHORITY TO DEVELOP AND EXECUTE COMPACT. On
 1-26 behalf of this state, the governor may develop and execute an
 1-27 interstate compact for the liquefied natural gas industry among
 1-28 states that border the Gulf of America.

1-29 Sec. 760.002. CONGRESSIONAL APPROVAL NOT REQUIRED. (a) It
 1-30 is the intent of the legislature that the compact developed and
 1-31 executed under this chapter not require congressional approval.

1-32 (b) The compact may not increase the political power of the
 1-33 compacting states in relation to the federal government.

1-34 Sec. 760.003. INTERSTATE COMPACT PROVISIONS. The compact
 1-35 authorized by this chapter must provide for joint action among
 1-36 compacting states on matters that include sharing information,
 1-37 resources, and services to:

1-38 (1) protect and grow the liquefied natural gas
 1-39 industry along the gulf coast; and

1-40 (2) improve coordination to increase the overall
 1-41 effectiveness and efficiency of the liquefied natural gas industry
 1-42 along the gulf coast.

1-43 SECTION 2. This Act takes effect immediately if it receives
 1-44 a vote of two-thirds of all the members elected to each house, as
 1-45 provided by Section 39, Article III, Texas Constitution. If this
 1-46 Act does not receive the vote necessary for immediate effect, this
 1-47 Act takes effect September 1, 2025.
