BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 658.001, Government Code, is amended by adding Subdivision (3) to read as follows:

"Telework" means a work arrangement that allows an employee of a state agency to conduct on a regular basis all or some agency business at a place other than the employee's regular or assigned temporary place of employment during all or a portion of the employee's established work hours.

SECTION 2. Section 658.010(a), Government Code, is amended to read as follows:

- (a) An employee of a state agency shall, during normal office hours, conduct agency business only at the employee's regular or assigned temporary place of employment unless the employee:
  - is travelling; or (1)
- administrative head of the employing state agency to perform work elsewhere 1.

SECTION 3. Chapter 658, Government Code, is amended by adding Sections 658.011 and 658.012 to read as follows:

Sec. 658.011. AUTHORIZATION OF TELEWORK. The (a) administrative head of a state agency may enter into an agreement with an employee authorizing telework in order to:
(1) address a lack of available office space for the

agency; or

(2)provide reasonable flexibility that enhances the agency's ability to achieve its mission.
