1-19 A BILL TO BE ENTITLED
1-20 AN ACT

1-21 relating to restrictions on freight and shipping costs included in
1-22 the price of instructional materials for public schools.

1-23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-24 SECTION 1. Section 31.151(a), Education Code, is amended to
1-25 read as follows:

1-26 (a) A publisher or manufacturer of instructional materials:

1-27 (1) shall furnish any instructional material the
1-28 publisher or manufacturer offers in this state at a price that does
1-29 not exceed the lowest price at which the publisher offers that
1-30 instructional material for adoption or sale to any state, public
1-31 school, or school district in the United States;

1-32 (2) shall automatically reduce the price of
1-33 instructional material sold for use in a school district or
1-34 open-enrollment charter school to the extent that the price is
1-35 reduced elsewhere in the United States;

1-36 (3) shall provide any instructional material or
1-37 ancillary item free of charge in this state to the same extent that
1-38 the publisher or manufacturer provides the instructional material
1-39 or ancillary item free of charge to any state, public school, or
1-40 school district in the United States;

1-41 (4) may not include in the price of instructional
1-42 material a freight and shipping cost that:

1-43 (A) exceeds the actual cost of delivering the
1-44 instructional material, as determined based on the standard rate
1-45 published by the carrier for the specified delivery method of the
1-46 instructional material; or

1-47 (B) includes a handling or similar charge that is
1-48 not directly related to the shipment of physical copies of the
1-49 instructional material;

1-50 (5) [+4] shall guarantee that each copy of
1-51 instructional material sold in this state is at least equal in
1-52 quality to copies of that instructional material sold elsewhere in
1-53 the United States and is free from factual error;

1-54 (6) [+5] may not become associated or connected with,
1-55 directly or indirectly, any combination in restraint of trade in
1-56 instructional materials or enter into any understanding or
1-57 combination to control prices or restrict competition in the sale
1-58 of instructional materials for use in this state;

1-59 (7) [+6] shall deliver instructional materials to a
1-60 school district or open-enrollment charter school;

1-61 (8) [+7] shall, at the time an order for

2-1 instructional materials is acknowledged, provide to school
2-2 districts or open-enrollment charter schools an accurate shipping
2-3 date for instructional materials that are back-ordered;

2-4 (9) [48] shall guarantee delivery of instructional
2-5 materials at least 10 business days before the opening day of school
2-6 of the year for which the instructional materials are ordered if the
2-7 instructional materials are ordered by a date specified in the
2-8 sales contract;

2-9 (10) [49] shall submit to the State Board of
2-10 Education an affidavit certifying any instructional material the
2-11 publisher or manufacturer offers in this state to be free of factual
2-12 errors at the time the publisher executes the contract required by
2-13 Section 31.026; and

2-14 (11) [410] shall comply with all other standard terms
2-15 and conditions adopted by the State Board of Education for use in
2-16 contracts for the procurement of instructional materials under
2-17 Subsection (a-1).

2-18 SECTION 2. This Act takes effect September 1, 2025.
