1-14 HOUSE CONCURRENT RESOLUTION

1-15 WHEREAS, Due to the lack of action by the federal government,
 1-16 the State of Texas has been forced to continually appropriate funds
 1-17 to secure the southern border of the United States; and

1-18 WHEREAS, In March 2021, Governor Greg Abbott launched
 1-19 Operation Lone Star to address record levels of migrant crossings
 1-20 and drug trafficking at the southern border; over the last three
 1-21 years, Texas has invested billions of dollars into the initiative;
 1-22 these funds have supported a variety of efforts, such as
 1-23 implementing surveillance technologies, providing resources to
 1-24 local law enforcement agencies, conducting legal and
 1-25 administrative activities, and managing the public health and
 1-26 humanitarian aspects of migration; and

1-27 WHEREAS, As part of Operation Lone Star, members of the Texas
 1-28 National Guard and the Texas Department of Public Safety have been
 1-29 deployed to the region to help detect and repel illegal crossings,
 1-30 arrest human smugglers and cartel gang members, and stop the flow of
 1-31 deadly drugs such as fentanyl into the United States; the program
 1-32 has led to more than 516,300 apprehensions of illegal immigrants
 1-33 and over 45,300 arrests; and

1-34 WHEREAS, Although it is the duty of the federal government to
 1-35 secure the nation's borders, the State of Texas has expended
 1-36 significant resources to help maintain safety and security across
 1-37 the United States, and Congress should take responsibility for its
 1-38 failure to address the crisis at the southern border; now,
 1-39 therefore, be it

1-40 RESOLVED, That the 89th Legislature of the State of Texas
 1-41 hereby respectfully urge the Congress of the United States to
 1-42 reimburse the State of Texas for border security costs incurred
 1-43 under Operation Lone Star; and, be it further

1-44 RESOLVED, That the Texas secretary of state forward official
 1-45 copies of this resolution to the president of the United States, to
 1-46 the president of the Senate and the speaker of the House of
 1-47 Representatives of the United States Congress, and to all the
 1-48 members of the Texas delegation to Congress with the request that
 1-49 this resolution be officially entered in the Congressional Record
 1-50 as a memorial to the Congress of the United States of America.
