BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subchapter B, Chapter 407A, Labor Code, amended by adding Section 407A.0521 to read as follows: 1-25 is 1-26

Sec. 407A.0521. NEW CERTIFICATES OF APPROVAL PROHIBITED. Notwithstanding Section 407A.052, the commissioner may not 1-27 1-28 <u>(a</u>) issue a certificate of approval to a proposed group on or after 1-29 1-30 September 1, 2025.
