1-17 relating to the authority of the Harris County Hospital District to
 1-18 employ and commission peace officers.
 1-19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
 1-20 SECTION 1. Section [281.057\(a\)](#), Health and Safety Code, is
 1-21 amended to read as follows:
 1-22 (a) The board of the Dallas County Hospital District, the
 1-23 Tarrant County Hospital District, the Bexar County Hospital
 1-24 District, ~~or~~ the El Paso County Hospital District, or the Harris
 1-25 County Hospital District may employ and commission peace officers
 1-26 for the district.
 1-27 SECTION 2. Article [2A.001](#), Code of Criminal Procedure, is
 1-28 amended to read as follows:
 1-29 Art. 2A.001. PEACE OFFICERS GENERALLY. The following are
 1-30 peace officers:
 1-31 (1) a sheriff, a sheriff's deputy, or a reserve deputy
 1-32 sheriff who holds a permanent peace officer license issued under
 1-33 Chapter [1701](#), Occupations Code;
 1-34 (2) a constable, a deputy constable, or a reserve
 1-35 deputy constable who holds a permanent peace officer license issued
 1-36 under Chapter [1701](#), Occupations Code;
 1-37 (3) a marshal or police officer of a municipality or a
 1-38 reserve municipal police officer who holds a permanent peace
 1-39 officer license issued under Chapter [1701](#), Occupations Code;
 1-40 (4) a ranger, officer, or member of the reserve
 1-41 officer corps commissioned by the Public Safety Commission and the
 1-42 director of the Department of Public Safety;
 1-43 (5) an investigator of a district attorney's, criminal
 1-44 district attorney's, or county attorney's office;
 1-45 (6) a law enforcement agent of the Texas Alcoholic
 1-46 Beverage Commission;
 1-47 (7) a member of an arson investigating unit
 1-48 commissioned by a municipality, a county, or the state;
 1-49 (8) an officer commissioned under Section [37.081](#),
 1-50 Education Code, or Subchapter [E](#), Chapter [51](#), Education Code;
 1-51 (9) an officer commissioned by the Texas Facilities
 1-52 Commission;
 1-53 (10) a law enforcement officer commissioned by the
 1-54 Parks and Wildlife Commission;
 1-55 (11) an officer commissioned under Chapter [23](#),

 2-27 (21) an officer commissioned by the governing body of
 2-28 a metropolitan rapid transit authority under Section 451.108,
 2-29 Transportation Code, or a regional transportation authority under
 2-30 Section 452.110, Transportation Code;
 2-31 (22) an investigator commissioned by the attorney
 2-32 general under Section 402.009, Government Code;
 2-33 (23) a security officer or investigator commissioned
 2-34 as a peace officer under Chapter 466, Government Code;
 2-35 (24) an officer appointed by an appellate court under
 2-36 Subchapter F, Chapter 53, Government Code;
 2-37 (25) an officer commissioned by the state fire marshal
 2-38 under Chapter 417, Government Code;
 2-39 (26) an investigator commissioned by the commissioner
 2-40 of insurance under Section 701.104, Insurance Code;
 2-41 (27) an apprehension specialist or inspector general
 2-42 commissioned by the Texas Juvenile Justice Department as an officer
 2-43 under Section 242.102 or 243.052, Human Resources Code;
 2-44 (28) an officer appointed by the inspector general of
 2-45 the Texas Department of Criminal Justice under Section 493.019,
 2-46 Government Code;
 2-47 (29) an investigator commissioned by the Texas
 2-48 Commission on Law Enforcement under Section 1701.160, Occupations
 2-49 Code;
 2-50 (30) a fire marshal or any related officer, inspector,
 2-51 or investigator commissioned by a county under Subchapter B,
 2-52 Chapter 352, Local Government Code;
 2-53 (31) a fire marshal or any officer, inspector, or
 2-54 investigator commissioned by an emergency services district under
 2-55 Chapter 775, Health and Safety Code;
 2-56 (32) an officer commissioned by the State Board of
 2-57 Dental Examiners under Section 254.013, Occupations Code, subject
 2-58 to the limitations imposed by that section; and
 2-59 (33) an investigator commissioned by the Texas
 2-60 Juvenile Justice Department as an officer under Section 221.011,
 2-61 Human Resources Code.
 2-62 SECTION 3. This Act takes effect immediately if it receives
 2-63 a vote of two-thirds of all the members elected to each house, as
 2-64 provided by Section 39, Article III, Texas Constitution. If this
 2-65 Act does not receive the vote necessary for immediate effect, this
 2-66 Act takes effect September 1, 2025.
