1-22 A BILL TO BE ENTITLED
1-23 AN ACT

1-24 relating to the appearance of a personal identification certificate
1-25 or driver's license issued to a person who is not a citizen of the
1-26 United States.

1-27 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-28 SECTION 1. Subchapter E, Chapter 521, Transportation Code,
1-29 is amended by adding Section 521.1017 to read as follows:

1-30 Sec. 521.1017. DESIGNATOR ON CERTIFICATE ISSUED TO
1-31 NONCITIZEN. A personal identification certificate issued to a
1-32 person who is not a citizen of the United States must:

1-33 (1) orient the information on the certificate to
1-34 clearly distinguish the certificate from a personal identification
1-35 certificate issued to a person who is a citizen; and

1-36 (2) display the phrase "NOT ELIGIBLE TO VOTE" on the
1-37 front of the certificate in the same font size as the individual's
1-38 personal identification certificate number.

1-39 SECTION 2. Subchapter F, Chapter 521, Transportation Code,
1-40 is amended by adding Section 521.1231 to read as follows:

1-41 Sec. 521.1231. DESIGNATOR ON LICENSE ISSUED TO NONCITIZEN.
1-42 A driver's license issued to an applicant who is not a citizen of
1-43 the United States must:

1-44 (1) orient the information on the license vertically,
1-45 regardless of the age of the applicant, to clearly distinguish the
1-46 license from a driver's license issued to a person who is a citizen;
1-47 and

1-48 (2) display the phrase "NOT ELIGIBLE TO VOTE" on the
1-49 front of the license in the same font size as the individual's
1-50 driver's license number.

1-51 SECTION 3. The changes in law made by this Act apply only to
1-52 a personal identification certificate or driver's license issued or
1-53 renewed on or after the effective date of this Act. A personal
1-54 identification certificate or driver's license issued or renewed
1-55 before the effective date of this Act is governed by the law in
1-56 effect when the license or certificate was issued or renewed, and
1-57 the former law is continued in effect for that purpose.

1-58 SECTION 4. This Act takes effect September 1, 2025.
