1-20 AN ACT

1-21 relating to a prohibition on e-cigarette advertising in certain  
1-22 locations.

1-23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-24 SECTION 1. The heading to Subchapter K, Chapter 161, Health  
1-25 and Safety Code, is amended to read as follows:

1-26 SUBCHAPTER K. PROHIBITION OF CERTAIN CIGARETTE, E-CIGARETTE, OR  
1-27 TOBACCO PRODUCT ADVERTISING; FEE

1-28 SECTION 2. Section 161.121, Health and Safety Code, is  
1-29 amended by adding Subdivision (2-a) to read as follows:

1-30 (2-a) "E-cigarette" has the meaning assigned by  
1-31 Section 161.081.

1-32 SECTION 3. Sections 161.122(a), (b), and (e), Health and  
1-33 Safety Code, are amended to read as follows:

1-34 (a) Except as provided by this section, a sign containing an  
1-35 advertisement for cigarettes, e-cigarettes, or tobacco products  
1-36 may not be located closer than 1,000 feet to a church or school.

1-37 (b) The measurement of the distance between the sign  
1-38 containing an advertisement for cigarettes, e-cigarettes, or  
1-39 tobacco products and an institution listed in Subsection (a) is  
1-40 from the nearest property line of the institution to a point on a  
1-41 street or highway closest to the sign, along street lines and in  
1-42 direct lines across intersections.

1-43 (e) Subsection (a) does not apply to a sign containing an  
1-44 advertisement for cigarettes, e-cigarettes, or tobacco products  
1-45 that, before September 1, 1997, was located closer than 1,000 feet  
1-46 to a church or school but that was not located closer than 500 feet  
1-47 to the church or school.

1-48 SECTION 4. This Act takes effect September 1, 2025.
