BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 301.053, Agriculture Code, is amended to read as follows:

Sec. 301.053. ADVISORY <u>BOARDS</u> [<u>COMMITTEES</u>]. The Texas Department of Licensing and Regulation may establish advisory <u>boards</u> [<u>committees</u>] to advise the Texas Department of Licensing and Regulation and to make recommendations to the Texas Department of Licensing and Regulation concerning legislation, policies, administration, research, and other matters related to the duties, powers, or functions of the Texas Department of Licensing and Regulation under this chapter.

SECTION 2. Section 1001.058, Education Code, is amended to read as follows:

Sec. 1001.058. ADVISORY <u>BOARD</u> [<u>COMMITTEE</u>]. (a) The commission shall establish an advisory <u>board</u> [<u>committee</u>] to advise the commission and department on rules and educational and technical matters relevant to the administration of this chapter.

 (3) exempt from the registration requirements imposed by this chapter, except as provided by Section 1152.102.
