1-21 relating to the issuance of specialty license plates to state and
 1-22 federal judges.

1-23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-24 SECTION 1. Section 504.403, Transportation Code, as amended
 1-25 by Chapter 1296 (H.B. 2357), Acts of the 82nd Legislature, Regular
 1-26 Session, 2011, and repealed by Chapter 1290 (H.B. 2017), Acts of the
 1-27 82nd Legislature, Regular Session, 2011, is reenacted and amended
 1-28 to read as follows:

1-29 Sec. 504.403. STATE AND FEDERAL JUDGES. (a) The department
 1-30 shall issue specialty license plates for a current or visiting
 1-31 state or federal judge. Except as provided by Subsection (b), the
 1-32 [The] license plates must include the words "State Judge" or "U.S.
 1-33 Judge," as appropriate.

1-34 (b) A person entitled to license plates under this section
 1-35 may elect to receive license plates that do not include the words
 1-36 "State Judge" or "U.S. Judge."

1-37 (c) [~~(a)~~] In this section, "state[+]

1-38 [~~(2)~~] "State] judge" means:

1-39 (1) [~~(A)~~] a justice of the supreme court;

1-40 (2) [~~(B)~~] a judge of the court of criminal appeals;

1-41 (3) [~~(C)~~] a judge of a court of appeals of this state;

1-42 (4) [~~(D)~~] a district court judge;

1-43 (5) [~~(E)~~] a presiding judge of an administrative
 1-44 judicial district; or

1-45 (6) [~~(F)~~] a statutory county court judge.

1-46 SECTION 2. This Act takes effect September 1, 2025.
