- this section applies must submit to the commissioners court proposed primary and backup dates for the space flight activities.

 (c) To protect the public health, safety, and welfare, the governing body of a municipality or the commissioners court, as applicable, under Subsection (b) or the commissioners court under Subsection (b-1) by ordinance or order may temporarily close a beach in reasonable proximity to the [launch] site of space flight activities or access points to the heach in the county on a primary activities or access points to the beach in the county on a primary
- or backup [launch] date for space flight activities, subject to Subsections [Subsection] (d), (e), and (h).

 (d) The governing body of a municipality or the commissioners court may not close a beach or access points to the beach for space flight activities on a [primary launch] date consisting of any of the following days without the approval of the land office:
 - (1)the Saturday or Sunday preceding Memorial Day;
 - (2)Memorial Day;
 - (3)July 4;
 - Labor Day; or (4)
- a Saturday or Sunday that is after Memorial Day but (5) before Labor Day.
- (e) When closing a beach or access point under this section, the governing body of a municipality and the [The] commissioners court must comply with:
- (1) the beach closure restrictions described in the Federal Aviation Administration's environmental evaluation of the site;
