- 9 Sec. 1101.006. APPLICATION OF SUNSET ACT. The Texas Real
- 10 Estate Commission is subject to Chapter 325, Government Code (Texas
- 11 Sunset Act). Unless continued in existence as provided by that
- 12 chapter, the commission is abolished and this chapter, [and]
- 13 Chapter 1102, and Chapter 1303 of this code and Chapter 221,
- 14 Property Code, expire September 1, 2019 [2007].
- 15 SECTION 2. Subchapter A, Chapter 1101, Occupations Code, is
- amended by adding Section 1101.007 to read as follows:
- 17 Sec. 1101.007. COMPLIANCE WITH SUNSET RECOMMENDATIONS. (a)
- 18 The commission shall:
- 19 (1) comply with and implement the management action

- 14 Section 1101.053, Occupations Code, regarding the prohibitions on
- or qualifications of members of the Texas Real Estate Commission do
- 16 not affect the entitlement of a member serving on the commission
- immediately before September 1, 2007, to continue to serve and
- 18 function as a member of the commission for the remainder of the
- 19 member's term. The changes in law made by that section apply only
- to a member appointed on or after September 1, 2007.
- 21 (b) The changes in law made by this Act regarding the
- 22 filing, investigation, or resolution of a complaint under Chapter
- 23 1101, Occupations Code, as amended by this Act, apply only to a
- 24 complaint filed with the Texas Real Estate Commission on or after
- 25 the effective date of this Act. A complaint filed before the
- 26 effective date of this Act is governed by the law as it existed
- 27 immediately before that date, and the former law is continued in

1 effect for that purpose.

- The change in law made by this Act regarding conduct is grounds for imposition of a disciplinary sanction, including a refund, temporary license suspension, or cease and desist order, applies only to conduct that occurs on or after the effective date of this Act. Conduct that occurs before the effective date of this Act is governed by the law in effect on the date the conduct occurred, and the former law is continued in effect for that purpose.
 - (d) The changes in law made by this Act regarding the procedure for an administrative penalty apply only to a proceeding commenced on or after the effective date of this Act. A proceeding commenced before the effective date of this Act is governed by the law in effect on the date the proceeding commenced, and the former law is continued in effect for that purpose.
 - (e) The change in law made by this Act regarding the renewal of an expired license applies only to a license that expires on or after the effective date of this Act. A license that expires before the effective date of this Act is governed by the law in effect on the date the license expired, and the former law is continued in effect for that purpose.
 - (f) The change in law made by this Act regarding accreditation standards for educational programs under Chapter 1101, Occupations Code, as amended by this Act, applies only to an accreditation granted or renewed on or after September 1, 2009. An educational program renewing an accreditation on or after the effective date of this Act but before September 1, 2009, should

- 1 strive to meet the new accreditation standards under Chapter 1101,
- Occupations Code, as amended by this Act, but an accreditation
- 3 granted or renewed before September 1, 2009, is governed by the law
- 4 in effect on the date the accreditation expired, and the former law
- 5 is continued in effect for that purpose.
- 6 (g) The change in law made by this Act to the authority of
- 7 the Texas Real Estate Inspector Committee to develop and recommend
- 8 rules under Chapter 1102, Occupations Code, as amended by this Act,
- 9 applies only to a rule proposed for adoption on or after the
- 10 effective date of this Act. A rule proposed for adoption before the
- 11 effective date of this Act is governed by the law in effect on the
- 12 date the rule was proposed for adoption, and the former law is
- 13 continued in effect for that purpose.
