4	SECTION 1. Subchapter A, Chapter 43, Election Code, is
5	amended by adding Section 43.007 to read as follows:
6	Sec. 43.007. COUNTYWIDE POLLING PLACE PROGRAM. (a) The
7	secretary of state shall implement a program to allow each
8	commissioners court participating in the program to eliminate
9	county election precinct polling places and establish countywide
10	polling places for:
11	(1) each general election for state and county
12	officers;
13	(2) each countywide election held on the uniform
14	election date in May;
15	(3) each election on a proposed constitutional
16	amendment; and
17	(4) each election of a political subdivision located
18	in the county that is held jointly with an election described by
19	Subdivision (1), (2), or (3).
20	(b) The commissioners court of a county that desires to
21	participate in the program authorized by this section shall hold a
22	public hearing on the county's participation in the program. The
23	commissioners court shall submit a transcript or electronic
24	recording of the public comments made at the hearing to the

1 secretary of state. A county that has previously participated in a 2 similar program and held a public hearing on the county's 3 participation in that program is not required to hold a hearing 4 under this subsection. 5 (c) In conducting the program, the secretary of state shall provide for an audit of the direct recording electronic voting 6 7 units before and after the election, and during the election to the 8 extent such an audit is practicable. 9 The secretary of state shall select to participate in (d) 10 the program each county that: (1) has held a public hearing under Subsection (b); 11 12 (2) has submitted documentation listing the steps taken to solicit input on participating in the program by 13 14 organizations or persons who represent the interests of voters; 15 (3) has implemented a computerized voter registration list that allows an election officer at the polling place to verify 16 17 that a voter has not previously voted in the election; (4) uses direct recording electronic voting machines; 18 19 and (5) is determined by the secretary of state to have the 20 appropriate technological capabilities. 21 22 (e) Each countywide polling place must allow a voter to vote in the same elections in which the voter would be entitled to vote 23 24 in the county election precinct in which the voter resides. (f) In selecting countywide polling places, a county must 25 26 adopt a methodology for determining where each polling place will be located. The total number of countywide polling places may not 27

1 be less than: 2 (1) except as provided by Subdivision (2), 50 percent 3 of the number of precinct polling places that would otherwise be located in the county for that election; or 4 5 (2) for an election held in the first year in which the county participates in the program, 65 percent of the number of 6 7 precinct polling places that would otherwise be located in the county for that election. 8 9 (g) A county participating in the program must establish a 10 plan to provide notice informing voters of the changes made to the locations of polling places under the program. The plan must 11 12 require that notice of the location of the nearest countywide polling place be posted on election day at each polling place used 13 in the previous general election for state and county officers that 14 15 is not used as a countywide polling place. (h) In adopting a methodology under Subsection (f) or 16 17 creating the plan under Subsection (g), the county shall solicit input from organizations or persons located within the county who 18 19 represent minority voters. (i) The secretary of state may only select to participate in 20 the program three counties with a population of 100,000 or more and 21 two counties with a population of less than 100,000. 22 (j) Not later than January 1 of each odd-numbered year, the 23 24 secretary of state shall file a report with the legislature. The report must include any complaints or concerns regarding a specific 25 26 election that have been filed with the office of the secretary of state before the preparation of the report and any available 27

Subchapter E, Chapter 172, Election Code, is 7 amended by adding Section 172.127 to read as follows: 8 Sec. 172.127. CONTENT OF SIGN USED TO IDENTIFY POLLING PLACE LOCATION. (a) This section applies only to a polling place 9 used to hold an election for more than one political party. 10 (b) A sign used to indicate the location of a polling place 11 12 for a primary election or a primary runoff election must either: (1) not contain the name of, or symbol representing, 13 14 any political party that is holding an election at the polling 15 place; or 16 (2) contain each name of, or each symbol representing, 17 a political party that is holding an election at the polling place. 18 SECTION 3. This Act takes effect September 1, 2009.
