- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Subsection (a), Section 204.052, Occupations
- 5 Code, is amended to read as follows:
- 6 (a) The physician assistant board consists of  $\frac{13}{12}$  [nine]
- 7 members appointed by the governor with the advice and consent of the
- 8 senate as follows:
- 9 (1) <u>seven</u> [three] practicing physician assistant
- 10 members who each have at least five years of clinical experience as
- 11 a physician assistant;
- 12 (2) three physician members who are licensed in this
- 13 state and who supervise physician assistants; and
- 14 (3) three public members who are not licensed as a
- 15 physician or physician assistant.
- 16 SECTION 2. Subsection (a), Section 204.054, Occupations
- 17 Code, is amended to read as follows:
- 18 (a) Members of the physician assistant board are appointed
- 19 for staggered six-year terms. The terms of <u>four or five</u> [three]
- 20 members, as applicable, expire on February 1 of each odd-numbered
- 21 year.
- SECTION 3. Section 204.055, Occupations Code, is amended to
- 23 read as follows:
- Sec. 204.055. OFFICERS. The governor shall designate a

- 1 physician assistant member of the physician assistant board as the
- 2 presiding officer of the board to serve in that capacity at the will
- 3 of the governor. The physician assistant board shall select from
- 4 its membership a secretary to serve a one-year term.
- 5 SECTION 4. Not later than November 1, 2013, the governor
- 6 shall appoint four members to the physician assistant board as
- 7 provided by Subdivision (1), Subsection (a), Section 204.052,
- 8 Occupations Code, as amended by this Act, as follows:
- 9 (1) one member for a term expiring February 1, 2015;
- 10 (2) one member for a term expiring February 1, 2017;
- 11 and
- 12 (3) two members for terms expiring February 1, 2019.
- 13 SECTION 5. If, on the effective date of this Act, the
- 14 presiding officer of the physician assistant board does not meet
- 15 the qualifications for office as presiding officer under Section
- 16 204.055, Occupations Code, as amended by this Act, the presiding
- 17 officer is removed from office as presiding officer on that date.
- 18 As soon as practicable on or after the effective date of this Act,
- 19 the governor shall appoint a presiding officer who meets the
- 20 qualifications under Section 204.055, Occupations Code, as amended
- 21 by this Act.
- 22 SECTION 6. This Act takes effect September 1, 2013.
