HB 730 Raymond | et al.
Relating to the training for and use of electromagnetic pulse devices by peace officers and reserve law enforcement officers.

HB 3096 Thompson, Senfronia
Relating to the exemption from use of an emergency notification system by public service providers.

HB 267 Miles
Relating to municipal civilian complaint review boards.

HB 2897 Miller, Doug
Relating to an integrated intelligence system to aid state and local law enforcement agencies in locating and arresting fugitives; authorizing a fee.

HB 2883 Muñoz, Jr.
Relating to the establishment of a regional center for public safety excellence in the Rio Grande Valley.

HB 1174 Fallon
Relating to the penalties for illegally passing a stopped school bus.

HB 438 Dutton
Relating to the courts authorized to issue an occupational driver's license.

HB 1931 Guillen | et al.
Relating to the compensation of property owners whose property is damaged as a result of a suspect fleeing apprehension by a peace officer.

HB 2102 Guillen | et al.

Relating to the authority of the governor to suspend requirements applicable to motor carriers during certain emergencies; authorizing a fee.

HB 1109 Burkett

Relating to peace officer interaction with persons with mental illness.

HB 3805 Gonzales, Larry

Relating to the discharge of an officer or employee of the Department of Public Safety of the State of Texas.

HB 2381 Isaac

Relating to the carrying of a concealed handgun by a license holder on certain premises.

HB 3142 Bell

Relating to handguns used to demonstrate proficiency in handgun use for purposes of obtaining a concealed handgun license.

HB 3218 Springer

Relating to the places where a person may carry a handgun if the person is licensed to carry a concealed handgun.

HB 3219 Springer

Relating to the places where an elected official who is licensed to carry a concealed handgun may carry a concealed handgun.

HB 1747 Canales | et al.

Relating to a packaging notice for new firearms and firearm ammunition; imposing a criminal penalty.

HB 1816 Cortez

Relating to lighting requirements for drivers during motor vehicle stops.
