S.B. No. 1122

A BILL TO BE ENTITLED

1 AN ACT

2 relating to a limitation on the authority to curtail groundwater  
3 production from wells used for power generation or mining.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 36.117, Water Code, is amended by adding  
6 Subsection (m) to read as follows:

7 (m) This subsection applies to a well that produces  
8 groundwater directly or indirectly used to support the operation of  
9 a power generation facility or a mine that provides fuel to a power  
10 generation facility, including production for dewatering, potable  
11 water, and depressurization. Except as a result of a permit  
12 amendment requested by the permit holder, a district may not reduce  
13 or curtail production from a well or limit the groundwater  
14 production rate of a well to a rate or amount that is less than:

15 (1) the maximum rate or amount of withdrawal as of  
16 September 1, 2014, authorized by the permit, whether the permit was  
17 issued by the district or the Railroad Commission of Texas; or

18 (2) the maximum annual historical rate or amount of  
19 withdrawal recorded before September 1, 2014, if the well was in  
20 operation on that date and no permit from any entity was required  
21 for the operation of the well.

22 SECTION 2. This Act takes effect immediately if it receives  
23 a vote of two-thirds of all the members elected to each house, as  
24 provided by Section 39, Article III, Texas Constitution. If this

- 2 Act takes effect September 1, 2015.
