Relating to the eligibility of certain defendants for release on personal bond.

Relating to the prosecution of the offense of sexual assault.

Relating to prosecution and punishment for the offense of official oppression by the intrusive touching of persons seeking access to public buildings and transportation; providing penalties.

Relating to the prosecution of the criminal offense of theft of service.

Relating to the prosecution of health care fraud.

Relating to orders of nondisclosure for certain victims of trafficking of persons.

Relating to the powers and duties of a personal bond or personal bond and pretrial supervision office.

Relating to creating the criminal offenses of obtaining medical treatment by deception for a child, elderly individual, or disabled individual and continuous abuse of a child, elderly individual, or disabled individual.

Relating to the amount of a fine and costs discharged by a defendant while confined in jail or engaged in labor.

Relating to the confinement of a defendant pending trial and detention or placement of a juvenile offender.
