15	(1) must be imprinted, stamped, or otherwise marked
16	with the specie's weight and purity and may be imprinted, stamped,
17	or otherwise marked with a name or symbol that identifies a refiner
18	or mint of the specie; and
19	(2) except for the information described by
20	Subdivision (1), may not be imprinted, stamped, or otherwise marked
21	with any name, symbol, or other information or design, including
22	any suggestion that the specie has been minted or issued by a
23	government.
24	(c) This section does not:

1	(1) restrict the electronic transfer of gold and
2	silver specie or gold and silver currency as legal tender for the
3	payment of a debt;
4	(2) apply to United States coins or currency issued or
5	recognized under federal law; or
6	(3) prohibit or limit the legal tender, acceptance, or
7	use of Federal Reserve notes in the payment of a debt.
8	(d) A person may not be required to offer or accept gold and
9	silver specie or gold and silver currency as legal tender for the
10	payment of a debt, for deposit, or for any other purpose.
11	Sec. 2116.102. TRANSACTIONAL CURRENCY. The comptroller may
12	establish or authorize one or more electronic systems that enable a
13	depositor or vendor to make and receive payments using a currency
14	backed by gold and silver bullion held in the depository.
15	Sec. 2116.103. CONTRACTING. The comptroller may contract
16	with one or more vendors to implement this subchapter. To the
17	extent consistent with state and federal law, in contracting with a
18	vendor under this section, the comptroller shall give preference to
19	a vendor whose principal place of business is in this state.
20	Sec. 2116.104. RULES. The comptroller shall adopt rules as
21	necessary or convenient to implement and administer this
22	subchapter, including rules to:
23	(1) provide for the security of transactions in gold
24	and silver specie and gold and silver currency and related

26	(2) determine the value of the gold and silver
27	currency described by Section 2116.102 at the time of a transaction

or in a commercially reasonable manner; 1 2 (3) establish a fee that is reasonable and necessary to administer this subchapter; 3 4 (4) authorize and approve vendors, including financial institutions, to provide an electronic system described 5 6 by Section 2116.102; and 7 (5) adopt policies and procedures to prevent: (A) fraud; and 8 9 (B) transactions in gold and silver specie or gold and silver currency involving a foreign adversary, or a person 10 associated with a foreign adversary, as determined under 15 C.F.R. 11 12 Section 791.4. SECTION 2. (a) Except as provided by Subsection (b) of this 13 14 section, this Act takes effect May 1, 2027. 15 (b) Section 2116.101, Government Code, as added by this Act,
