Relating to the rights and liabilities of the owner of the surface estate of the tract of land on which a well to be plugged or replugged by the Railroad Commission of Texas is located.

HB 3652 LaHood
Relating to a study by the Railroad Commission of Texas regarding the creation of a strategic gas and petroleum product reserve in this state.

HB 4572 Morales Shaw
Relating to the regulation by the Railroad Commission of Texas of certain pits used for the storage and disposal of oil and gas waste.

HB 4891 Morales, Eddie
Relating to the regulation by the Railroad Commission of Texas of certain commercial facilities that dispose of oil and gas waste; imposing a fee.

HB 5103 Rosenthal
Relating to the abandonment of mineral proceeds for purposes of certain unclaimed property laws.

Relating to the imposition on a payor of proceeds of production from an oil or gas well of a duty to notify a payee when payments to the payee are suspended.

Relating to the critical designation of certain natural gas facilities.

HB 5600 McLaughlin
Relating to the development and expansion of clean hydrogen production,
distribution, and utilization in this state.
