Relating to prohibiting the regulation of homeschool programs.

HB 3029 Howard
Relating to the administration of nonprescription medications to certain public and private school students.

HB 3460 Dutton
Relating to the bilingual education allotment under the public school finance system.

HB 3631 Hunter
Relating to a credit against required recapture payments for certain school districts for the cost of windstorm and hail insurance under the public school finance system.

HB 3662 Capriglione
Relating to the operation of an unmanned aircraft over a public school instructional facility; creating a criminal offense.

HB 5201 Lopez, Janie
Relating to requiring school districts ensure that project managers overseeing construction projects are bonded.

HB 5381 Lowe
Relating to protections for certain military dependents enrolled in a public school.
