Relating to a handbook on parental rights in education and training requirements on parental rights in education for a member of the board of trustees of a school district.

SB 570 Bettencourt | et al.
Relating to an attendance policy adopted by public schools to prevent truancy.

SB 735 Menéndez | et al.
Relating to Holocaust education and training provided to students enrolled at public schools and public institutions of higher education.

SB 747 King | et al. Posting Rule Suspended
Relating to public school policies and programs regarding the production or distribution of certain intimate visual material by public school students.

SB 784 King
Relating to the transfer of certain public school students who are children of peace officers.

SB 875 Birdwell | et al. Posting Rule Suspended
Relating to prohibiting election activities committed by a member of the board of trustees or superintendent of an independent school district or on certain school district premises; creating criminal offenses.

SB 1207 King | et al.
Relating to instruction on adoption in the parenting and paternity awareness program in public schools.

SB 1396 Hall | et al.
Relating to prohibiting the adoption or use of national sex education standards in public schools.

SB 1447 Menéndez | et al.
Relating to standards adopted by the Texas Education Agency regarding the use of electronic devices and software applications by public schools.

SB 2392 King
Relating to notice to local law enforcement of certain offenses occurring on public or private school property or at school-sponsored or school-related activities; providing a civil penalty.

SB 2540 Nichols
Relating to the terms of certain agreements involving minor boundary adjustments between two contiguous school districts.
