Relating to the prohibited manufacture, processing, possession, distribution, offer for sale, and sale of cell-cultured protein.

HB 3800 Or:

Relating to an advisory board established to develop a resource guide that facilitates collaboration in identifying and addressing local health care workforce needs.

HB 3801 Orr

Relating to the establishment of the Health Professions Workforce Coordinating Council and the abolition of the statewide health coordinating council and the nursing advisory committee of that council.

HB 3560 Pierson

Relating to criminal background check requirements for staff at certain licensed hospitals.

HB 3246 LaHood

Relating to a resilience training program for first responders and active duty military personnel.
